20 The Commissioner of Business Oversight finds that:

21 1. Respondent is a California Finance Lender licensed by the  
22 Commissioner of Business Oversight ("Commissioner") pursuant to the  
23 California Finance Lenders Law (California Financial Code § 22000 et seq.)  
24 ("CFL").

25 2. Pursuant to California Financial Code section 22112, all CFL  
26 licensees are required to maintain a surety bond in the minimum amount of  
27 \$25,000.00. The surety bond of respondent expired on October 27, 2013. On  
28

1 or about October 7, 2013, the Commissioner notified Respondent that a  
2 replacement surety bond had to be filed immediately, but no later than the  
3 expiration date to avoid suspension or revocation of its CFL license.

4 3. Respondent has not obtained a replacement surety bond in violation  
5 of California Financial Code section 22112.

6 4. Failure to maintain a surety bond is grounds under Financial Code  
7 section 22714 for the revocation of a license issued under the CFL.

8 5. On October 30, 2013, the Commissioner issued a Notice of Intention  
9 to Issue Order Revoking CFL license, Accusation, and accompanying  
10 documents against Respondent based upon the above; and respondent was  
11 served with those documents by certified mail, return receipt requested. The  
12 Department has received no request for a hearing from Respondent and the  
13 time to request for a hearing has expired.

14 NOW GOOD CAUSE APPEARING THEREFORE, it is hereby  
15 ordered that the CFL license issued to Respondent is hereby revoked. This  
16 order is effective as of the date hereof.
