DESIST AND REFRAIN ORDER
(For violations of section 25102.1(d) of the Corporations Code)

The California Corporations Commissioner finds that:

1. At all relevant times, Global Encryption Imaging Corporation is and was a Delaware corporation, incorporated on April 25, 2011. Global Encryption Imaging Corporation maintains an address at 24331 Muirlands Blvd. Suite D4-318, Lake Forest, CA 92630 and websites at www.globalencryptionimaging.com and www.theclearmark.com.
2. At all relevant times, Peter Reinert (“Reinert”) was the president and chief executive officer of Global Encryption Imaging Corporation.
3. Beginning in at least July 2011, Global Encryption Imaging Corporation and Reinert offered or sold securities in the form of stock in Global Encryption Imaging Corporation in California.
4. These securities were offered or sold in this state in issuer transactions. The Department of Corporations has not issued a permit or other form of qualification authorizing any person to offer or sell these securities in this state.

1 5. Global Encryption Imaging Corporation's subscription documents represent that the issuance
2 of securities in Global Encryption Imaging Corporation is made in reliance on Regulation D, Rule 506,
3 of the Securities Act of 1933.

4 6. Global Encryption Imaging Corporation and Reinert failed to file a Form D exemption notice,
5 consent to service of process, and filing fee with the California Corporations Commissioner pursuant
6 to California Corporations Code section 25102.1, subdivision (d).

8 Based upon the foregoing findings, the California Corporations Commissioner is of the opinion
9 that the investments that are being or have been offered or sold by Global Encryption Imaging
10 Corporation and Peter Reinert are securities subject to the requirements of section 25102.1,
11 subdivision (d), of the Corporate Securities Law of 1968 (California Corporations Code section 25000
12 et seq.). Furthermore, the California Corporations Commissioner is of the opinion that Global
13 Encryption Imaging Corporation and Peter Reinert have not met the requirements of section 25102.1,
14 subdivision (d), specifically, the filing of a Form D exemption notice, consent to service of process,
15 and filing fee with the California Corporations Commissioner. Pursuant to section 25532, subdivision
16 (a)(2), of the Corporate Securities Law of 1968, Global Encryption Imaging Corporation and Peter
17 Reinert are hereby ordered to desist and refrain from the further offer or sale of stock in Global
18 Encryption Imaging Corporation in the State of California, unless and until those requirements have
19 been met.

20 This Order is necessary, in the public interest, for the protection of investors and consistent
21 with the purposes, policies, and provisions of the Corporate Securities Law of 1968.
