DESIST AND REFRAIN ORDER
(For violations of sections 25110 and 25210 of the Corporations Code)

The California Commissioner of Business Oversight finds that:

1. At all relevant times, Real Source Solutions, Inc. was a California Corporation, with addresses at 5077 Lankershim Boulevard, Suite 500, North Hollywood, CA 91601 and 6400 Laurel Canyon Boulevard, Suite 300, North Hollywood, CA 91606.
2. At all relevant times, RSS, Inc. was a California Corporation, with an address at 6400 Laurel Canyon Boulevard, Suite 300, North Hollywood, CA 91606.
3. At all relevant times, Real Source Solutions, Inc. and RSS, Inc. conducted business under the name RSS Marketing.
4. At all relevant times, Gregory Doss was the CEO, President or a director of Real Source Solutions, Inc. Gregory Doss was the CEO or President of RSS, Inc.
5. Real Source Solutions, Inc. and RSS, Inc., individually and doing business as RSS Marketing and Gregory Doss offered or sold securities on behalf of third-party companies.
6. Real Source Solutions, Inc. and RSS, Inc., individually and doing business as RSS Marketing and Gregory Doss contacted potential investors over the telephone to induce those

1 investors to purchase securities in third-party companies. Real Source Solutions, Inc. and RSS, Inc.,
2 individually and doing business as RSS Marketing and Gregory Doss negotiated the sale of the
3 securities to the potential investors on behalf of third-party companies.

4 7. These securities were offered or sold in this state in issuer transactions. The
5 Department of Business Oversight has not issued a permit or other form of qualification authorizing
6 any person to offer or sell the securities referred to herein in this state.

7 8. The Department of Business Oversight has not issued a certificate authorizing Real
8 Source Solutions, Inc. and RSS, Inc., individually and doing business as RSS Marketing and Gregory
9 Doss to act as a broker-dealer. Real Source Solutions, Inc. and RSS, Inc., individually and doing
10 business as RSS Marketing and Gregory Doss are not exempt from the certification requirement
11 under section 25210 of the Corporation Securities Law of 1968 (California Corporations Code section
12 25000 et seq.).

13 Based upon the foregoing findings, the California Commissioner of Business Oversight is of
14 the opinion that the securities being offered or sold by Real Source Solutions, Inc. and RSS, Inc.,
15 individually and doing business as RSS Marketing and Gregory Doss are securities subject to
16 qualification under the California Corporate Securities Law of 1968 and are being or have been
17 offered or sold without qualification in violation of Corporations Code section 25110. Further,
18 pursuant to section 25403 of the Corporations Code, any person who controls or induces another
19 person to violate a provision of the Corporate Securities Law of 1968, or any person who provides
20 substantial assistance to another person in the violation of the Corporate Securities Law of 1968, shall
21 be liable for the violation. Pursuant to section 25532 of the Corporate Securities Law of 1968, Real
22 Source Solutions, Inc. and RSS, Inc., individually and doing business as RSS Marketing and Gregory
23 Doss are hereby ordered to desist and refrain from the further offer or sale of securities in the State of
24 California unless and until qualification has been made under the law or unless exempt.

25 The California Commissioner of Business Oversight is also of the opinion that Real Source
26 Solutions, Inc. and RSS, Inc., individually and doing business as RSS Marketing and Gregory Doss
27 have induced or attempted to induce the purchase or sale of securities as broker-dealers without having
28 first applied for and secured from the Commissioner a certificate, authorizing these persons to act in

1 that capacity, in violation of section 25210 of the Corporate Securities Law of 1968 (California
2 Corporations Code section 25000 et seq.). Pursuant to section 25532 of the Corporate Securities Law
3 of 1968, Real Source Solutions, Inc. and RSS, Inc., individually and doing business as RSS Marketing
4 and Gregory Doss are hereby ordered to desist and refrain from effecting any transaction in, or
5 inducing or attempting to induce the purchase or sale of, any securities in this state, unless and until
6 they have applied for and secured from the Commissioner a certificate, then in effect, authorizing
7 these persons to act in that capacity.

9 This Order is necessary, in the public interest, for the protection of investors and consistent
10 with the purposes, policies, and provisions of the Corporate Securities Law of 1968.
