**DESIST AND REFRAIN ORDER**  
**(For violations of section 25110 of the Corporations Code)**

The California Corporations Commissioner finds that:

1. Gary W. Adkisson is the owner and manager of Readiness Technology Partners, LLC, a California corporation first incorporated on February 24, 2009, with a registered address of 137 Canyon Drive, Napa, California 94559. Gary W. Adkisson is the subject of a prior Desist and Refrain Order issued by the California Department of Corporations on October 8, 2010 for violations of Corporations Code sections 25110, 25120 and 25401 based on his involvement in the offer and sale of securities issued by other companies he owned and managed including The Continuum Clubs, Inc., Proaction Concepts, LLC and Proaction Sports Medicine Concepts, LP. 2. In or about 2009, Gary W. Adkisson and Readiness Technology Partners, LLC offered and sold investments in the form of shares of stock in Readiness Technology Partners, LLC to members of the public. According to offering materials, Readiness Technology Partners, LLC was a start up company that offered personalized online fitness training programs for “first responders” such as firefighters, police, EMTs and other government jobs, which require physical training as a job requirement. The company would purportedly offer a proprietary training method referred to as the “ReadyFit Technology System” which government and other agencies would subscribe to for their employees and which claimed to allow individual physical training plans to be developed and monitored for each employee which would be administered online by Readiness Technology Partners, LLC.

1           3. The investments offered and sold by Gary W. Adkisson and Readiness Technology  
2 Partners, LLC and their agents, including shares of stock in Readiness Technology Partners, LLC  
3 constitute securities. The Department of Corporations has not issued a permit or other form of  
4 qualification authorizing any person to offer and sell these securities in this state.

5                       Pursuant to section 25532 of the Corporate Securities Law of 1968, Gary W. Adkisson  
6 and Readiness Technology Partners, LLC are hereby ordered to desist and refrain from offering or  
7 selling or buying or offering to buy any security in the State of California, including but not limited to  
8 shares of stock in Readiness Technology Partners, LLC, unless and until qualification of those shares  
9 of stock have been made under the law or unless exempt.

10           This Order is necessary, in the public interest, for the protection of investors and consistent  
11 with the purposes, policies, and provisions of the Corporate Securities Law of 1968.
