#### STATEMENT OF REASONS WHY CHANGES IN THE REGULATIONS AS SET FORTH IN CHAPTER 1, TITLE 10, CALIFORNIA CODE OF REGULATIONS ARE CHANGES WITHOUT REGULATORY EFFECT

As required by title 1, California Code of Regulations, section 100 of the rules the Commissioner of the Department of Business Oversight (Commissioner) sets forth below the reasons for the nonsubstantive amendments to Chapter 1, title 10, California Code of Regulations and why the changes do not materially alter any requirement, right, responsibility, condition, prescription, or other regulatory element of any California Code of Regulations provision.

On July 1, 2013, the Department of Corporations and the Department of Financial Institutions merged to form the Department of Business Oversight. The Department of Business Oversight (Department) has all of the powers, authority, enforcement, jurisdiction, laws and regulations that were under the former Department of Corporations and former Department of Financial Institutions.

The Department of Business Oversight licenses and regulates businesses engaged in financial transactions that were under the former Department of Corporations, such as mortgage loan originators, deferred deposit providers, securities broker-dealers, investment advisers and certain fiduciaries and lenders, franchises and the offer and sale of securities. The Department of Business Oversight also oversees the operations of state-licensed financial institutions under the jurisdiction of the former Department of Financial Institutions, including banks, credit unions, industrial banks, savings associations, trust companies, foreign banking organizations, business and industrial development corporations, and money transmitters.
