6 reinstatement is granted provided that the following condition is met by Petitioner within fifteen (15)  
7 days of the day hereof:

8                     Payment of a penalty in the amount of \$2,500.00 for failure to file its 2016 annual report  
9                     as required by Financial Code section 22159, subdivision (a).

10           The total amount of \$2,500.00 must be made payable in the form of a cashier’s check or  
11 Automated Clearing House deposit to the “Department of Business Oversight,” and transmitted to the  
12 attention of Accounting – Litigation, at the Department of Business Oversight, 1515 K Street, Suite  
13 200, Sacramento, California 95814.
