1 On or about April 10, 2019, Patriot Capital Corporation doing business as Patriot Petroleum  
2 Capital (Patriot) filed a Petition for Reinstatement of its California Financing Law (CFL) license,  
3 which was revoked by the Commissioner of Business Oversight (Commissioner) on April 19, 2017,  
4 for failure to file its 2016 annual report as required by Financial Code section 22159, subdivision (a).

5 On July 24, 2019, the Commissioner notified the Attorney General of the filing of the Petition  
6 for Reinstatement and gave the parties until August 26, 2019, to present any written argument or  
7 supporting documentation. Neither party did so.

8 On August 29, 2019, the Commissioner granted the Petition for Reinstatement on the  
9 condition that Patriot pay a penalty in the amount of \$2,500.00 for failure to file its 2016 annual  
10 report as required by Financial Code section 22159, subdivision (a) within 15 days of the date of the  
11 order.

12 The Commissioner finds that Patriot has complied with all conditions for reinstatement of its  
13 license and is otherwise fit to engage in the business of finance lending.

14 THEREFORE, IT IS ORDERED that the Petition for Reinstatement is granted and Patriot  
15 Capital Corporation doing business as Patriot Petroleum Capital’s CFL license, license number  
16 6031859, is hereby reinstated effective as of the date of this Order.
