21 The Commissioner of Business Oversight (Commissioner) and Direct Funding Now LLC
22 (DFN), (collectively, Parties), enter into this Consent Order with respect to the following facts:

23 RECITALS

- 24 A. The Commissioner has jurisdiction over the licensing and regulation of persons and entities
25 engaged in the business of making consumer and commercial loans pursuant to the California
26 Financing Law (CFL) (Fin. Code, § 22000 et seq.).
27 B. DFN is a finance lender that was licensed by the Commissioner from February 4, 2019 to
28 December 29, 2019 (CFL License No. 60DBO-93189). DFN has its principal office located at 16485

1 Laguna Canyon, #140, Irvine, California 92618.

2 C. DFN has no branch locations in California.

3 D. Christian Murillo is the executive vice president and a control person of DFN and, as such, is
4 authorized to enter into this Consent Order on DFN's behalf.

5 E. In accordance with Financial Code section 22107, each finance lender, broker, or program
6 administrator licensee shall pay to the Commissioner its pro rata share of all costs and expenses,
7 including the costs and expenses associated with the licensing of mortgage loan originators it
8 employs, reasonably incurred in the administration of this division, as estimated by the
9 Commissioner, for the ensuing year and any deficit actually incurred or anticipated in the
10 administration of the program in the year in which the assessment is made. CFL licensees must pay
11 the annual assessment on or before the 31st day of October each year.

12 F. Pursuant to Financial Code section 22153, a licensee is required to submit a change of address
13 form 10 days prior to an address change.

14 G. On September 30, 2019, the Commissioner sent DFN the Assessment Notice per invoice
15 number CF1052. The notice was mailed to the address DFN registered with the Department
16 (Registered Address): 23411 Summerfield, Unit 42A, Aliso Viejo, California 92656. The notice
17 stated that the annual assessment would become delinquent if not paid by October 31, 2019.

18 H. As of October 31, 2019, DFN had not paid its annual assessment. The failure to pay the annual
19 assessment on or before October 31, 2019 represents a violation of Financial Code section 22107.

20 I. As of November 6, 2019, DFN had not paid its annual assessment. As a result, the
21 Commissioner sent to DFN's Registered Address a Notice of Unpaid Assessment on November 6,
22 2019. The notice warned that failure to pay the assessment would result in summary revocation of
23 DFN's license. DFN did not respond to the Commissioner's notice.

24 J. As of December 6, 2019, DFN had not paid its annual assessment. As a result, on December
25 6, 2019, the Commissioner issued an Order Summarily Revoking California Financing Law License
26 Pursuant to Financial Code Section 22107 for CFL License Number 60DBO-93189 (Revocation
27 Order). The Department mailed the Revocation Order to DFN's Registered Address along with notice
28 that it would become effective December 30, 2019 unless payment of the annual assessment was

1 received by close of business on December 27, 2019.

2 K. As of December 27, 2019, the assessment remained unpaid. As such, the Revocation Order
3 became effective December 30, 2019.

4 L. DFN stated that it did not receive the notices or the Revocation Order because it failed to
5 properly notify the Commissioner that it had changed its place of business to a street address other than
6 that designated on its license, as required by Financial Code section 22153.

7 M. In connection with these proceedings, DFN represented to the Commissioner that it had made
8 loans in California after its license had been revoked. As such, the Commissioner finds that DFN
9 engaged in the business of a finance lender in violation of Financial Code section 22100.

10 N. DFN admits to the jurisdiction of the Commissioner and it is the intention of the parties to
11 resolve this matter without the necessity of a hearing and/or other litigation.

12 O. The Commissioner finds that entering into this Consent Order is in the public interest and
13 consistent with the purposes fairly intended by the CFL.

14 NOW, THEREFORE, for good and valuable consideration, and the terms and conditions set
15 forth herein, the Parties agree as follows:

16 TERMS

17 1. Purpose. This Consent Order resolves the issues before the Commissioner described
18 above in a manner that avoids the expense of a hearing and other possible court proceedings,
19 protects consumers, is in the public interest, and is consistent with the purposes, policies, and
20 provisions of the CFL.

21 2. Desist and Refrain Order. Pursuant to Financial Code section 22712, DFN is hereby
22 ordered to desist and refrain from failing to timely pay the annual assessment in violation of
23 Financial Code section 22107.

24 3. Order Rescinding Revocation Order(s). The Commissioner hereby rescinds the
25 Revocation Order, which was issued on December 6, 2019, and became effective on December 30,
26 2019, as of the effective date of revocation.

27 4. Order to Pay Annual Assessment. Pursuant to Financial Code section 22107, the
28 Commissioner hereby orders DFN to pay \$250.00 to the Department of Business Oversight for the

1 2019 – 2020 annual assessment. The annual assessment shall be paid to the Commissioner within 30
2 days of the Effective Date of this Consent Order as defined in paragraph 23. The annual assessment
3 shall be labeled “2019 – 2020 annual assessment” and made payable in the form of a cashier’s check
4 or Automated Clearing House deposit to the “Department of Business Oversight,” and transmitted to
5 the attention of:

12 5. Administrative Penalties and Fines. DFN shall pay administrative fines and penalties in
13 the amount of \$5,000.00 for the violations of the CFL enumerated herein. All fines and penalties
14 shall be labeled “fines and penalties” and made payable in the form of a cashier’s check or
15 Automated Clearing House deposit to the “Department of Business Oversight,” and transmitted to
16 the attention of:

21 Notice of payment shall be made via email to Trevor Carroll, Counsel at Department of

23 6. Waiver of Hearing Rights. DFN acknowledges that the Commissioner is ready, willing,
24 and able to proceed with the filing of an administrative enforcement action on the charges contained
25 in this Consent Order. DFN hereby waives the right to any hearings, and to any reconsideration,
26 appeal, or other right to review which may be afforded pursuant to the CFL, the California
27 Administrative Procedure Act, the California Code of Civil Procedure, or any other provision of law.
28 DFN further expressly waives any requirement for the filing of an Accusation pursuant to
Government Code section 11415.60, subdivision (b). By waiving such rights, DFN effectively
consents to this Consent Order and Desist and Refrain Order becoming final.

1 7. Failure to Comply with Consent Order. DFN agrees that if it fails to comply with the
2 terms of this Consent Order, the Commissioner may, in addition to all other available remedies it
3 may invoke under the CFL, summarily suspend or revoke the CFL license of DFN until DFN is in
4 compliance. DFN waives any notice and hearing rights to contest such summary suspension which
5 may be afforded under the CFL, the California Administrative Procedure Act, the California Code of
6 Civil Procedure, or any other provision of law in connection therewith.

7 8. Information Willfully Withheld or Misrepresented. This Consent Order may be revoked
8 and the Commissioner may pursue any and all remedies available under law against DFN if the
9 Commissioner discovers that DFN knowingly or willfully withheld or misrepresented information
10 used for and relied upon in this Consent Order.

11 9. Future Actions by the Commissioner. If DFN fails to comply with any terms of the
12 Consent Order, the Commissioner may institute proceedings for any and all violations otherwise
13 resolved under this Consent Order. The Commissioner reserves the right to bring any future actions
14 against DFN, or any of its partners, owners, officers, shareholders, directors, employees or
15 successors for any and all unknown violations of the CFL.

16 10. Assisting Other Agencies. Nothing in this Consent Order limits the Commissioner's
17 ability to assist any other government agency (city, county, state, or federal) with any prosecution,
18 administrative, civil or criminal brought by that agency against DFN or any other person based upon
19 any of the activities alleged in this matter or otherwise.

20 11. Headings. The headings to the paragraphs of this Consent Order are inserted for
21 convenience only and will not be deemed a part hereof or affect the construction or interpretation of
22 the provisions hereof.

23 12. Binding. This Consent Order is binding on all heirs, assigns, and/or successors in
24 interest.

25 13. Reliance. Each of the parties represents, warrants, and agrees that in executing this
26 Agreement it has relied solely on the statements set forth herein and the advice of its own counsel.
27 Each of the parties further represents, warrants, and agrees that in executing this Agreement it has
28 placed no reliance on any statement, representation, or promise of any other party, or any other

1 person or entity not expressly set forth herein, or upon the failure of any party or any other person or
2 entity to make any statement, representation or disclosure of anything whatsoever. The parties have
3 included this clause: (1) to preclude any claim that any party was in any way fraudulently induced to
4 execute this Agreement; and (2) to preclude the introduction of parol evidence to vary, interpret,
5 supplement, or contradict the terms of this Agreement.

6 14. Waiver, Amendments, and Modifications. No waiver, amendment, or modification of
7 this Consent Order will be valid or binding unless it is in writing and signed by each of the parties.
8 The waiver of any provision of this Consent Order will not be deemed a waiver of any other
9 provision. No waiver by either party of any breach of, or of compliance with, any condition or
10 provision of this Consent Order by the other party will be considered a waiver of any other condition
11 or provision or of the same condition or provision at another time.

12 15. Full Integration. This Consent Order is the final written expression and the complete and
13 exclusive statement of all the agreements, conditions, promises, representations, and covenant
14 between the parties with respect to the subject matter hereof, and supersedes all prior or
15 contemporaneous agreements, negotiations, representations, understandings, and discussions
16 between and among the parties, their respective representatives, and any other person or entity, with
17 respect to the subject matter covered hereby.

18 16. Governing Law. This Consent Order will be governed by and construed in accordance
19 with California law. Each of the parties hereto consents to the jurisdiction of such court, and hereby
20 irrevocably waives, to the fullest extent permitted by law, the defense of an inconvenient forum to
21 the maintenance of such action or proceeding in such court.

22 17. Counterparts. This Consent Order may be executed in one or more separate counterparts,
23 each of which when so executed, shall be deemed an original. Such counterparts shall together
24 constitute a single document.

25 18. Effect Upon Future Proceedings. If DFN applies for any license, permit, or qualification
26 under the Commissioner's current or future jurisdiction, or is the subject of any future action by the
27 Commissioner to enforce this Consent Order, then the subject matter hereof shall be admitted for the
28 purpose of such application(s) or enforcement proceedings(s).

1 19. Voluntary Agreement. DFN enters this Consent Order voluntarily and without coercion
2 and acknowledges that no promises, threats or assurances have been made by the Commissioner or
3 any officer, or agent thereof, about this Consent Order. The parties each represent and acknowledge
4 that he, she or it is executing this Consent Order completely voluntarily and without any duress or
5 undue influence of any kind from any source.

6 20. Notice. Any notice required under this Consent Order be provided to each party at the
