25 Spectrum Funding Group, LLC (Spectrum) having filed a petition for reinstatement of its
26 California Financing Law (CFL) license (CFL license number 60DBO-86583), which was revoked
27 by the Commissioner of Business Oversight (Commissioner) on December 27, 2018, the petition
28 having been considered, no further argument submitted, and good cause appearing:

1 IT IS SO ORDERED that, subject to the Commissioner’s satisfactory review, the petition for
2 reinstatement is granted provided that within fifteen days of the date hereof Spectrum makes payment
3 of a penalty in the amount of \$2,500.00 for failure to pay its 2018-2019 annual assessment, as
4 required by Financial Code section 22107. The total amount of \$2,500.00 must be made payable in
5 the form of a cashier’s check or Automated Clearing House deposit to the “Department of Business
6 Oversight,” and transmitted to the attention of Accounting – Litigation, at the Department of
7 Business Oversight, 1515 K Street, Suite 200, Sacramento, California 95814. Notice of the payment
