21 Financial Code section 22715 provides that:

22 The Commissioner may by order summarily suspend or revoke the
23 license of any licensee if that person fails to file the report required by
24 Section 22159 within 10 days after notice by the Commissioner that
25 such report is due and not filed. If, after an order is made, a request for
26 hearing is filed in writing within 30 days and the hearing is not held
27 within 60 days thereafter, the order is deemed rescinded as of its

You are also ordered and directed to discontinue all activity conducted pursuant to Financial Code sections 22340 and 22600 within 60 days of the effective date of this Order.
