24	On March 2, 2021, the Commissioner notified the Attorney General of the filing of the
25	Petition and gave the parties until March 16, 2021, to present any written argument or supporting
26	documentation.
27	On March 17, 2021, the Commissioner granted the Petition on the condition that Puente

- 1. Pay a \$2,500.00 penalty for failing to pay the annual assessment in violation of Financial Code section 22107.
 - 2. Pay the \$250.00 annual assessment for 2019–2020.

THEREFORE, IT IS ORDERED that the Petition is granted and Puente Hills Financing's CFL license is reinstated, effective as of the date of this Order.
