23 January 6, 2020, Landmark Wall RR Ltd. (Landmark) filed with the Commissioner of Financial  
24 Protection and Innovation a petition for reinstatement of its California Financing Law (CFL)  
25 license. A copy of the petition is attached as Exhibit 1.

26 In an order that became effective on December 27, 2018, the Commissioner revoked  
27 Landmark’s CFL license because it failed to pay its annual assessment as required under Financial
