23 15, 2021, Chicago Mortgage Solutions Corporation (Chicago Mortgage) filed with the
24 Commissioner of Financial Protection and Innovation a petition for reinstatement of its California
25 Financing Law (CFL) license. A copy of the petition is attached as Exhibit 1.

26 In an order that became effective on December 27, 2017, the Commissioner revoked
27 Chicago Mortgage’s CFL license because it failed to pay its annual assessment as required under
28 Financial Code section 22107. A copy of the revocation order is attached as Exhibit 2.
