On January 22, 2021, Alta Capital Group, Inc. ("Alta Capital") filed with the Commissioner of Financial Protection and Innovation (Commissioner) a petition for reinstatement of its California Financing Law (CFL) license. The Commissioner revoked the CFL license of Alta Capital on December 30, 2019, after it failed to pay its annual assessment as required under Financial Code section 22107.

The petition having been considered, no further argument submitted, and good cause appearing,

1 IT IS ORDERED that, subject to the Commissioner's satisfactory review, Alta Capital's
2 petition for reinstatement of its CFL license is granted provided that the following conditions are met
3 by Alta Capital on or before November 5, 2021:

4 (1) Payment of penalties in the amount of \$2,500.00; and

5 (2) Payment of the annual assessment for the fiscal year 2019 – 2020 in the amount of
6 \$250.00.

7 The total amount of \$2,750.00 shall be paid by cashier's check or Automated Clearing House
8 deposit made payable to the Department of Financial Protection and Innovation and transmitted to the
9 attention of Accounting – Litigation at the Department of Financial Protection and Innovation, 2101
10 Arena Boulevard, Sacramento, California 95834. Notice of the payment must be sent to Jeremy F.
11 Koo, Counsel, at Jeremy.Koo@dfpi.ca.gov.
