(1) The Investment Adviser Certificate, CRD number 159804 issued to Infinity Capital Group, LLC, is revoked.

(2) The Investment Adviser Certificate, CRD number 6004136 issued to Shlomo Mordechai Bistritzky is revoked.

(3) Shlomo Mordechai Bistritzky is barred from any position of employment, management or control of any investment adviser, broker-dealer or commodity adviser, any officer, director, partner, employee of, or person performing similar functions for, an investment adviser, or any other person.

This Order is effective immediately.
