

5	surety bond	in the minimum amount of \$25,000.00.
6	4.	On or around March 16, 2022, the Commissioner received notice that Respondent's
7	surety bond	would expire on April 16, 2022.
8	5.	On August 19, 2022 the Commissioner notified Respondent that the Commissioner
9	would issue	a Desist and Refrain Order under Financial Code section 22712, subdivision (a) if the
10	surety bond was not reinstated, continued, or replaced by August 26, 2022.	
11	6.	Respondent's surety bond expired on April 16, 2022.
12	7.	Respondent has yet to replace or reinstate its surety bond in violation of Financial
