1 This Order is to remain in full force and effect until the further written order of the 2 Complainant. Section 22107 (d) of the Financial Code provides as follows: 3 4 If a licensee fails to pay the assessment on or before the 31st day of October, the commissioner may by order summarily suspend or revoke the certificate 5 issued to the licensee. If, after an order is made, a request for hearing is filed in writing within 30 days, and a hearing is not held within 60 days thereafter, 6 the order is deemed rescinded as of its effective date. During any period when 7 its certificate is revoked or suspended, a finance lender or broker licensee and any mortgage loan originator licensee employed by the finance lender or 8 broker shall not conduct business pursuant to this division except as may be permitted by order of the commissioner.
