The Commissioner of Financial Protection and Innovation (Commissioner) finds that:

On February 15, 2022, the Commissioner issued, among other things: (1) a Notice of Intention to Issue Order Barring Michael Francis Christianos from Any Position of Employment, Management, or Control of Any Finance Lender, Broker, or Mortgage Loan Originator Pursuant to Financial Code 22169; and (2) an Accusation in support thereof, which set forth the reasons and grounds for the intended Order (Pleadings).

- B. On November 9, 2022, the Commissioner served the Pleadings on Respondent Michael Francis Christianos (Christianos).
- C. Christianos has not requested a hearing, and the time to request a hearing has now expired.

NOW GOOD CAUSE APPEARING THEREFORE, it is hereby ordered that, pursuant to Financial Code section 22169, Michael Francis Christianos is hereby barred from any position of employment with, or management or control of, any finance lender, broker, program administrator, or any other person.
