21 The Commissioner of Financial Protection and Innovation (Commissioner) finds that:

22 A. On April 17, 2023, the Commissioner issued, among other things: (1) a Notice of
23 Intention to Issue Order Revoking California Financing Law License of Petro Vicart Inc. and (2) an
24 Accusation in support thereof, which set forth the reasons and grounds for the intended Order
25 (Pleadings).

26 B. On April 19, 2023, the Commissioner served the Pleadings on Respondent Petro
27 Vicart Inc. by sending a copy of the Pleadings by certified mail, return receipt requested, to Petro
28 Vicart Inc.’s last-known, principal place of business address and the address of Petro Vicart Inc.’s

1 registered agent for service of process. In addition, that same day, the Commissioner served a
2 second copy of the Pleadings by email to the email address designated by Petro Vicart Inc. with the
3 Commissioner—an email address that Petro Vicart Inc. is required to maintain and monitor.
4 Additionally, on May 17, 2023, the Commissioner re-served a copy of the Pleadings on Respondent
5 Petro Vicart Inc. by sending a copy of the Pleadings by certified mail, return receipt requested, to
6 Petro Vicart Inc.’s last-known, licensed address.

7 C. Petro Vicart Inc. has not requested a hearing, and the time to request a hearing has
8 expired.

9 NOW GOOD CAUSE APPEARING THEREFORE, it is hereby ordered that:

10 Pursuant to Financial Code section 22714, the California Financing Law license of Petro
11 Vicart Inc., license number 60DBO-104523, is hereby revoked.

12 This Order is effective as of the date hereof.
