17	The Complainant, the Commissioner of Financial Protection and Innovation	
18	(Commissioner) finds that:	
19	1. BREEZE LOANS LLC (Respondent) is a finance lender and/or broker licensed by	
20	the Commissioner pursuant to the California Financing Law (Fin. Code, § 22000 et seq.).	
21	Respondent's principal place of business is 306 South Washington Avenue, Suite 207, Royal Oak,	
22	Michigan 48067.	
23	2. Pursuant to Financial Code section 22712, CFL licensees are required to maintain a	
24	surety bond in the minimum amount of \$25,000.00.	
25	3. On or around November 2, 2023 the Commissioner received notice that	
26	Respondent's surety bond would expire on December 5, 2023.	
27	4. On January 9, 2024, the Commissioner notified Respondent that a replacement	
28	surety bond had to be filed no later than the cancellation date to avoid suspension or revocation of	

its CFL license.

- 5. Respondent's surety bond expired on December 5, 2023.
- 6. Respondent has yet to replace or reinstate its surety bond in violation of Financial Code section 22112.
- 7. On March 26, 2024 the Commissioner issued a Notice of Intention to Issue Order Revoking CFL License, Accusation, and accompanying documents to Respondent. Respondent was served with those documents by certified mail, return receipt requested, regular mail, and electronic mail. The Commissioner has not received any request for a hearing from Respondent and the time to request a hearing has expired.

NOW GOOD CAUSE APPEARING THEREFORE, it is hereby ordered that the finance lender and/or broker license issued to BREEZE LOANS LLC is hereby revoked. This ORDER is effective as of the date hereof.
