9 DESIST AND REFRAIN ORDER  
10 (For violations of Financial Code section 22100)

11 The Commissioner of Financial Protection and Innovation (Commissioner) finds that:

12 1. At all relevant times, National Funding Solutions is and was an entity of unknown form doing  
13 business in California, with a stated address of 1157 Fincham Road San Diego, CA 92111, and a  
14 telephone number of +1 619-853-5128. National Funding Solutions was doing business in California  
15 by offering loans to California consumers. There is no record of any corporate filings for an entity  
16 named National Funding Solutions in California.

17 2. National Funding Solutions maintains a website at <https://nationalfundingsolutions.com/>.  
18 There, National Funding Solutions states that it provides “up to \$2,000,000 in Business Loans,” and  
19 that it has “funded over \$2 billion dollars over the course of 9 years, helping more than 3,800  
20 businesses grow.” The website states, “National Funding Solutions was founded in 2014 – in  
21 California. We’ve helped more than 3,800 businesses thrive and prosper with access to fast and easy  
22 capital, with over \$2 billion in funding amount.” However, the website was created on September 05,  
23 2023.

24 3. National Funding Solutions has not been issued a license by the Commissioner authorizing  
25 them to engage in the business of a finance lender and/or broker under the California Financing Law  
26 (Fin. Code, §22000 et seq.), nor are they exempt from the licensing requirements of Financial Code  
27 section 22100.

28 By reason of the foregoing, National Funding Solutions has engaged in the business of a  
finance lender and/or broker without having first obtained a license from the Commissioner in

1 violation of Financial Code section 22100. Pursuant to Financial Code section 22712, National  
2 Funding Solutions is ordered to desist and refrain from engaging in the business of a finance lender  
3 and/or broker in the State of California without first obtaining a license from the Commissioner, or  
4 otherwise being exempt.

5 This order is necessary, in the public interest, for the protection of California borrowers, and  
6 is consistent with the purposes, policies, and provisions of the California Financing Law.
